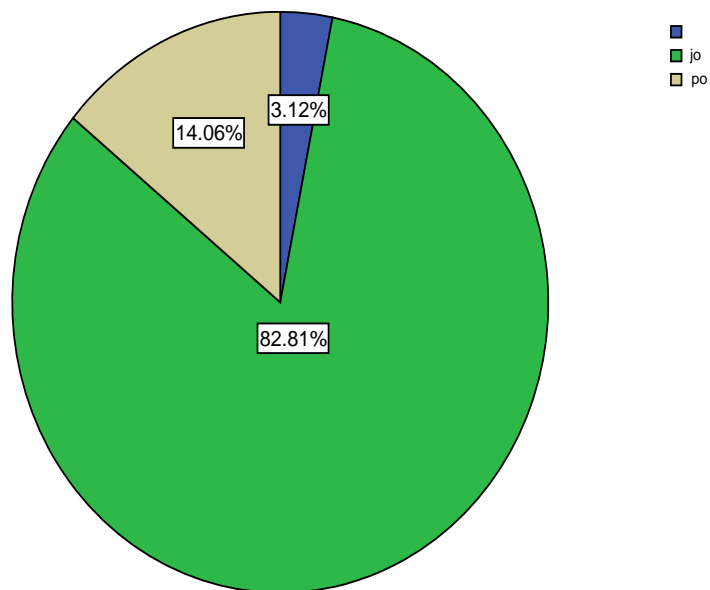

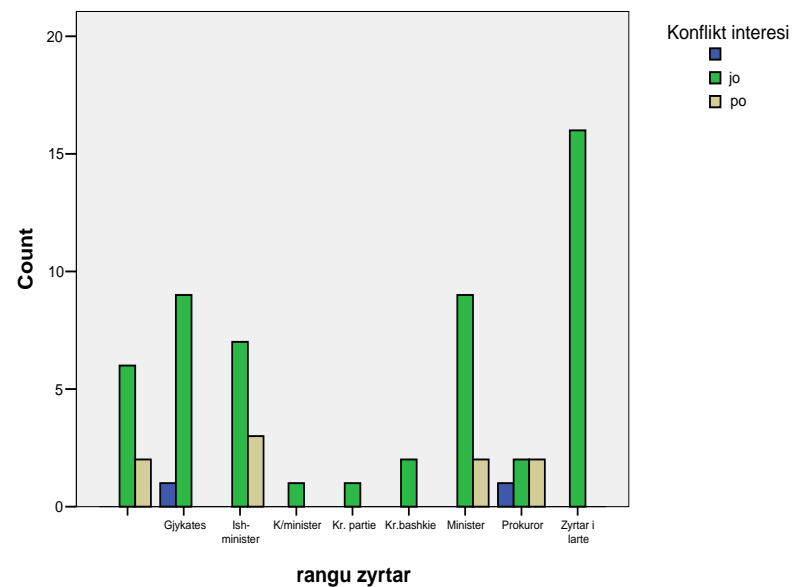

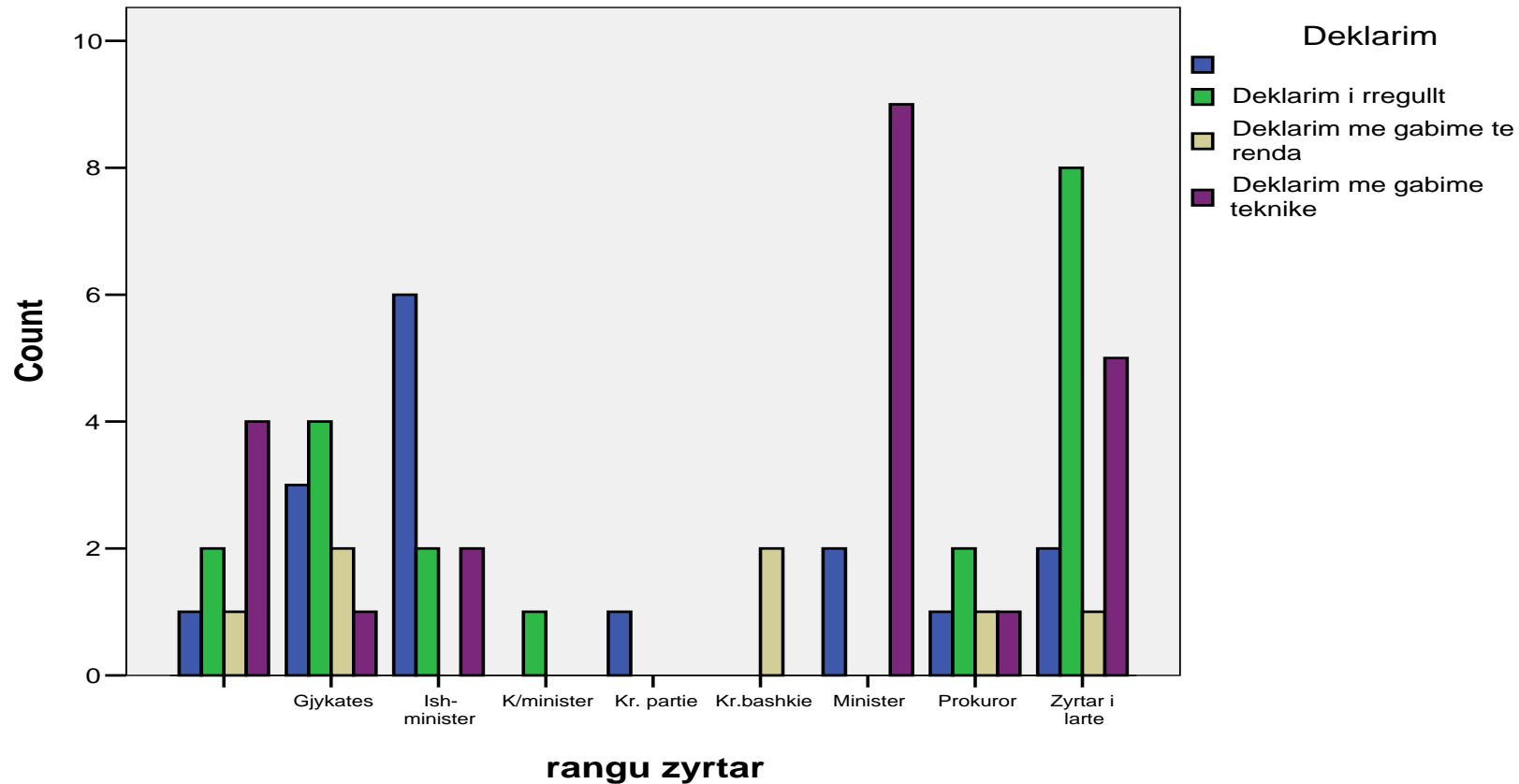

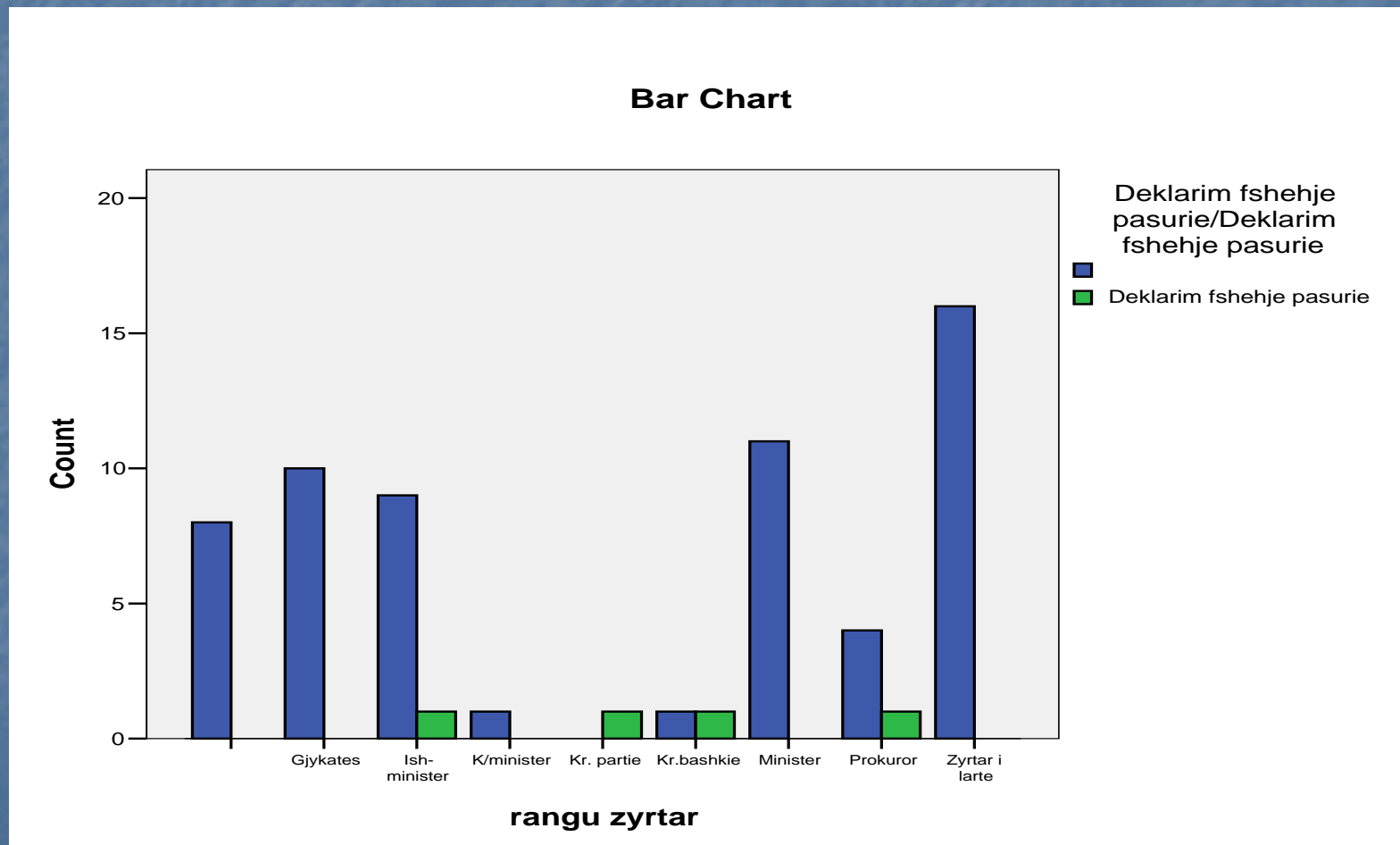


Kush thote me shume te verteten

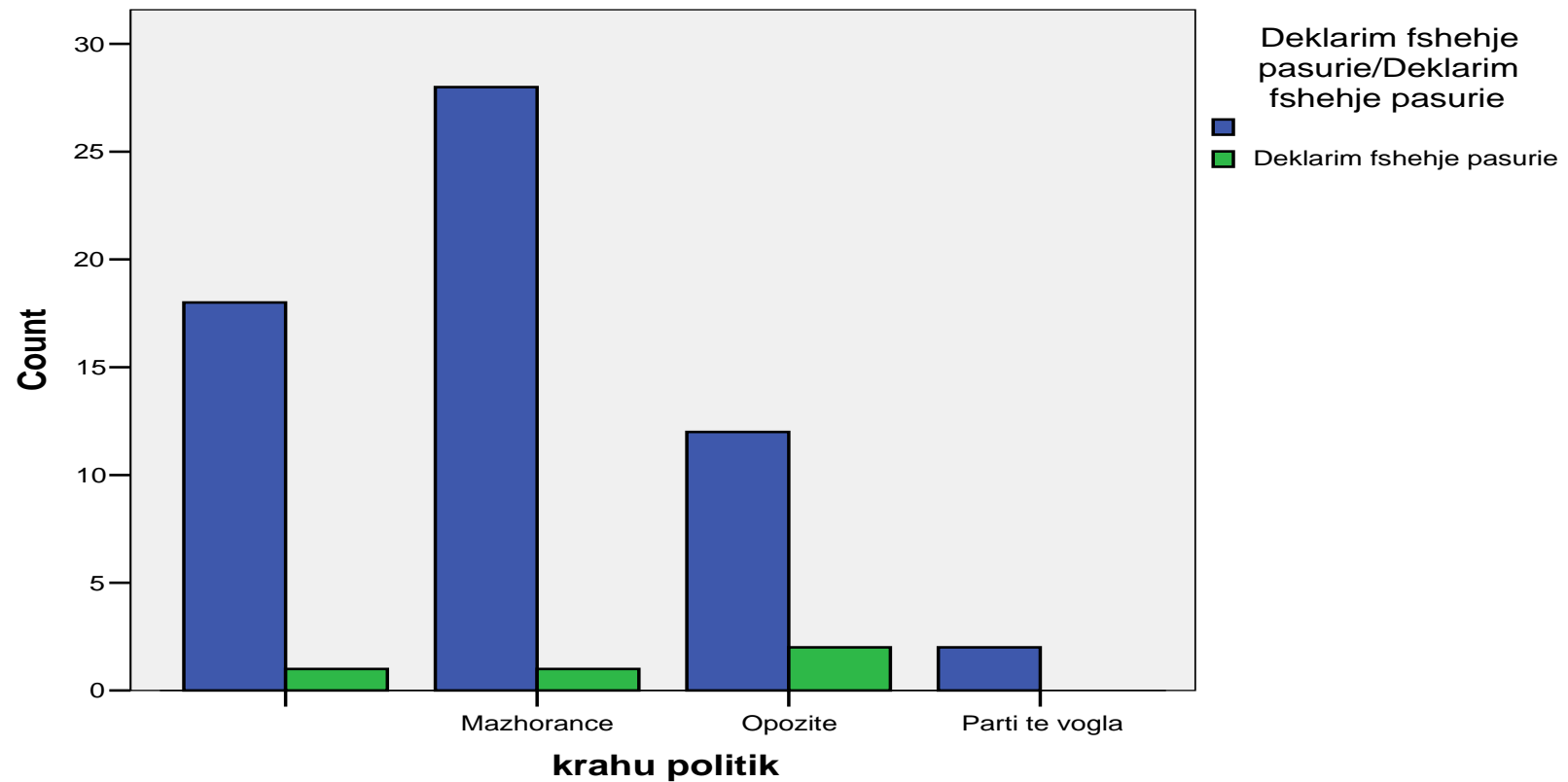


Kush ka thene me pak te verteten



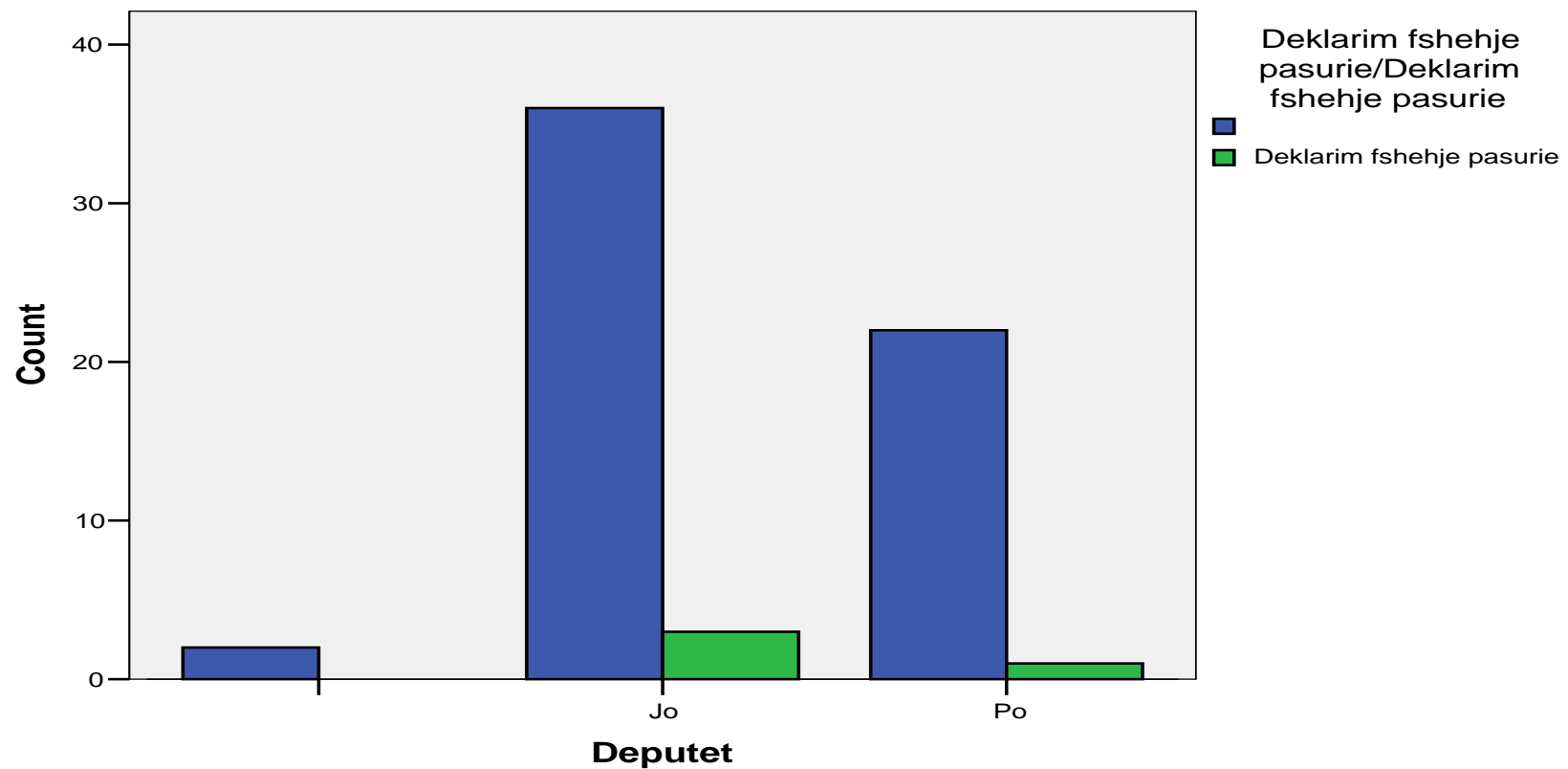
Kush ka fshehur me shume pasuri

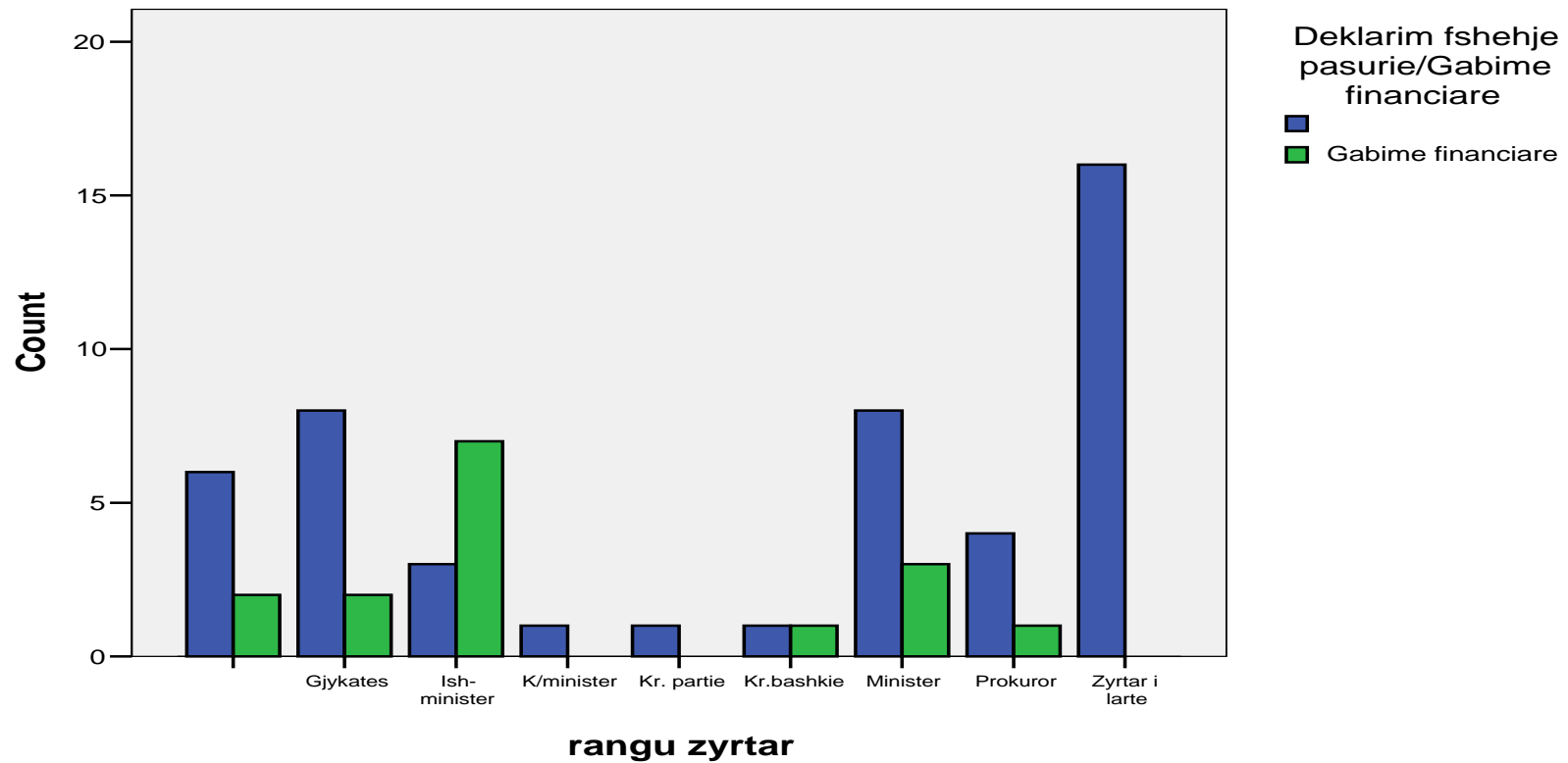
Kush ka deformuar me shume, deputetet apo zyrtaret e tjere
